- 4.0 Prior to construction of the Telecommunications facility commencing on the site, the Lease Agreement is to be executed between the parties and a Plan of Survey endorsed by Council and registered with the State government.
- 5.0 The Lease area is to be clearly delineate with survey pegs, to the boundary of the Lease area, to ensure the development is contained within the Lease area at all times.

PART B - MATERIAL CHANGE OF USE

- **1.0** Carry out the approved development generally in accordance with the approved drawing(s) and in accordance with:
 - (a) specifications, facts and circumstances as set out in the application submitted to Council; and
 - (b) the following conditions of approval and the requirements of Council's Planning Scheme and other relevant Local Laws and policies. except where modified by these conditions of approval.
- 2.0 The exterior finishes and colours of the facility must be non-reflective and must blend with the natural colours of the surrounding environment.
- 3.0 The perimeter of the lease area, as survey pegged, must be fenced with a minimum 1.8 metre high mesh security fence and gates the facility is to be signed with appropriate hazard and warning signs.
- **4.0** An underground connection to electricity supply must be provided.
- 5.0 The conditions of the development permit must be actioned prior to commencement of the use, except where specified otherwise in these conditions of approval.
- 6.0 During construction of the facility all construction vehicles, such as trucks and cranes are to be contained on the Lease area or in close proximity to the Lease area on Lot 522 and not disrupt the flow of traffic on Old School Road or Butler Bay Road.
- **7.0** Construction and operation of the facility must comply with the following legislation and standards:
 - Telecommunications Act 1997;
 - Telecommunications Code of Practice 1997;
 - Communications Alliance Ltd Mobile phone base station deployment C564-2011;
 - EME report findings;
 - Australian standard 1055 -background noise levels
 - Civil Aviation Safety Regulations 1998, Manual of Standards, Part 139,
 Chapter 7 Obstacle Restriction and Limitation.
- 8.0 The facility must comply with all relevant State and National standards in relation to emission of light, vibration, odour and radiation. The Telecommunication facility must be operated in accordance with radio communications (electromagnetic radiation human exposure, standard 2003. in relation to the limits for continuous exposure of the general public to radio frequencies electromagnetic energy or other standard of the Commonwealth of Australia more relevant at the time.
- 9.0 Confirmation is to be provided to Council in writing confirming that under section 24KA of the Native Title Act the facility is accepted as providing services to the public and procedural rights have been given.

- **10.0** During construction and operation of the facility all public assets and future public assets, including those shown on the Strategic framework map, are to be protected and any damage to public assets is to be repaired at no cost to Council.
- **11.0** At the time the facility is constructed the following external works are also required to be constructed adjacent to the Lease area frontage:
 - Profiling of the adjacent road frontage of the Lease area, ensuring that water runoff to the surrounding area is not increased or any potential for ponding is avoided or minimized.
- 12.0 The approved development lapses at the expiry of the agreement to lease the land from the landowner or entity from which a lease may be attained and prior to the lapse of the life of the approval the Telecommunications facility and all associated infrastructure, buildings, structures and fencing on the Lease area must be decommissioned and removed and the area/land reinstated to its original condition.
- **13.0** All costs associated with the decommissioning and final removal shall be borne by the applicant or entity that operates the tower at the time of removal.
